

# Sanford Cloud Awards for Diverse Advocacy, Policy, and Equity: A Funding Opportunity for CT Health Fellows and Leaders

The Connecticut Health Foundation (CT Health) has invested in the development of over 200 leaders from diverse backgrounds for over 10 years with a focus on health equity, systems change, and advocacy. These leaders are advancing important health equity efforts in their communities, regionally, and across the state of Connecticut. The Sanford Cloud Awards for Diverse Advocacy, Policy, and Equity are designed to advance health equity for people of color by investing in initiatives led by the foundation's Fellows and Leaders as they apply lessons learned and skills gained from the Health Leadership Fellows Program and Academy for Health Equity Advocacy and Leadership to advance systems change for health equity.

#### **Funding Opportunity Details**

#### Goal

CT Health's network of over 200 leaders are agents of change advancing health equity in a variety of ways. This grant opportunity seeks to invest in the work of the foundation's leaders to advance health equity and drive change that can be replicated and scaled across the state.

#### Objectives

- Advance health equity by supporting fellow and leader-initiated projects that have the potential for scalable and sustainable impact across the state of Connecticut
- Apply lessons learned and skill gained from the leadership program to address real-world problems
- Foster engagement, collaboration, and collective impact among the Fellows/Leaders network

#### **Project Examples**

- Engaging an expert or consultant to support efforts to address racism as a public health issue
- Implementing a diversity, equity, and inclusion (DEI) initiative in your organization to learn best practices to advance a health equity lens, including documentation and dissemination for other organizations interested in undertaking similar DEI work
- Advocacy trainings to mobilize community members around a specific health equity policy goal

#### Selection Criteria

- Alignment with CT Health's strategic plan
- Demonstration of specific health equity issue or problem
- Feasibility of the project
- Magnitude of impact, including ability to replicate and sustain models past grant funding
- Appropriateness of requested budget
- Collaborations between two or more fellows/leaders are encouraged

#### Timeline and Funding

CT Health will fund grants of between \$2,500 to \$10,000 each. **Applications will be accepted on a rolling basis through August 18, 2023.** A total of \$20,000 will be made available to support this grant program.



#### Eligibility

This funding opportunity is exclusively available to graduates of CT Health's Health Leadership Fellows Program or Academy for Health Equity Advocacy and Leadership. Fellows and leaders must apply through a 501(c)(3) organization.

#### Reporting

Grantees will be required to submit an interim and final report. Awardees may also be asked to present their projects at Fellows/Leaders events.
